Introduction

AL AIN JUNIORS SCHOOL is committed to providing a high-quality education by offering **two distinct curricula** to meet the diverse needs of our students: the **CBSE (Central Board of Secondary Education)** and **Cambridge Assessment International Education (CAIE)**. These curricula are delivered separately, with **CBSE** catering to students following the Indian educational system, while the **Cambridge** curriculum caters to students seeking an international qualification. Both curricula meet the academic and developmental needs of students from **Kindergarten to Grade 12 (K-12)** and are aligned with the standards set by the **Abu Dhabi Department of Education and Knowledge (ADEK)**.

Additionally, our school ensures compliance with the **UAE Ministry of Education (M.O.E.) regulations**, incorporating the mandatory M.O.E. subjects, including **Islamic Studies, Arabic Language, and Social Studies** (UAE History and Civics) into our curriculum. This policy ensures that we are in full alignment with the educational framework set by ADEK and the UAE government.

This policy outlines the school's approach to curriculum planning, delivery, assessment, and continuous improvement, ensuring that both the **CBSE** and **Cambridge** curricula are aligned with ADEK's educational standards and UAE National Agenda.

Vision and Mission

Vision:

To provide a globally relevant, high-quality education that prepares students for success in an ever-changing world, fostering intellectual, emotional, and social development.

Mission:

To deliver an inclusive, innovative, and culturally responsive curriculum that meets the needs of all learners and supports the UAE's Vision 2021 and ADEK's educational framework.

Curriculum Framework

Al Ain Juniors school offers **separate** curricula for **CBSE** and **Cambridge**, ensuring that all students have access to an educational pathway that best suits their needs, interests, and academic goals.

CBSE Curriculum:

The CBSE curriculum follows a structured approach that aligns with the educational policies (NEP 2020, NCF 2023) of the Government of India. It promotes a comprehensive academic framework, with a focus on inquiry, conceptual understanding, and application of knowledge across all subjects. CBSE is particularly focused on preparing students for national examinations and college admissions.



Cambridge Curriculum:

The Cambridge curriculum follows the international standards set by **Cambridge Assessment International Education (CAIE)**, with an emphasis on developing critical thinking, problem-solving, and research skills. The Cambridge curriculum offers a global perspective, allowing students to be prepared for international qualifications such as the O Levels, IGCSE AS and A-Level examinations.

Both curricula are taught separately for **K-12 students**, with appropriate adjustments made for the different educational stages (Kindergarten, Primary, and Secondary).

Additionally, the **Ministry of Education (M.O.E.) subjects** are integrated into both curricula pathways to ensure compliance with national requirements. These subjects include:

- **Islamic Studies** (for Muslim students)
- **Arabic Language**
- **Social Studies** (UAE History, Civics, and National Identity)/MSCS

Curriculum Planning and Implementation

Integration and Separation of CBSE and Cambridge Curricula

The school ensures **separate delivery** of the **CBSE** and **Cambridge** curricula for all grade levels.

While the **CBSE curriculum** is implemented as per the prescribed guidelines from the Central Board of Secondary Education, the **Cambridge curriculum** follows the structured approach of Cambridge International.

Each curriculum operates within its own framework and timeline but ensures that all students, regardless of the pathway they follow, have access to **quality teaching** and opportunities for **academic excellence**.

Curriculum Design and Development

For both curricula, subjects such as **English, Mathematics, Science, and Social Studies** are taught according to the prescribed content and guidelines.

The school ensures that the **mandatory M.O.E. subjects** are integrated into both curricula pathways, following the **UAE Ministry of Education** guidelines to ensure full compliance with local regulations.

Ongoing Professional Development for Teachers

Teachers will receive subject-specific training to ensure they are well-equipped to teach either the **CBSE** or **Cambridge** curricula.

The school ensures that all **PE teachers** receive **75 hours of Continuous Professional Development (CPD)** per year in alignment with **ADEK guidelines**.

Teachers will be supported in their professional growth through **workshops**, **seminars**, and collaboration with **external experts** who specialize in CBSE and Cambridge subjects.
